WHEREAS, Park County anticipates receiving \$566,403.00 in Forest Reserve monies from the State of Colorado, Department of Treasury, and said monies have been deposited in the Park County Treasurer's account titled Undistributed Forest Reserve Account 03.0000.206800; and,

WHEREAS, Park County has elected that an additional \$62,304.00 be held by the Federal Forest Service for Title II projects and be distributed by a RAC board, and,

WHEREAS, it is necessary to distribute this amount to the School Districts within the County and the County Road and Bridge Fund and a special use account for forest related use Title III funds; and,

WHEREAS, the Board of County Commissioners, for the County of Park, Colorado must determine the distribution of these monies in accordance with Colorado Revised Statutes, Section 30-29-101, 1973, as amended, and,

WHEREAS, said statutes provide that monies for School Districts shall be apportioned according to each District's enrollment compared to the total; and,

WHEREAS, School Districts and the appropriate percentage as established by the Certification of County Public School Fund Allocations FY 2014-15:

<u>School District</u>	<u>10/1/2014 Enrollment</u>	<u>Percent of Allocation</u>
RE 1 - Bailey	1,017	61%
RE 2 - Fairplay	651	39%
Total	1,668	100%

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS FOR THE COUNTY OF PARK that:

The balance of \$504,099.00 in the Undistributed Forest Reserve Account be distributed in the following manner plus the \$62,304.00 held by the Federal Forest Service:

- 15.0% of \$566,403.00 for a total payment of \$84,961.00 be distributed to Park County Road and Bridge;
- 42.7% of \$566,403.00 for a total payment of \$241,740.00 be distributed to Park County RE 1 School District (Bailey); and
- 27.3% of \$566,403.00 for a total payment of \$154,742.00 be distributed to Park County RE 2 School District (Fairplay)
- 11% of \$566,403.00 for a total payment of \$62,304.00 to be distributed by RAC board for Title II forest projects
- 4% of \$566,403.00 for a total payment of \$22,656.00 be distributed to a special forest use account for Title III projects
