Resolution No. 2019 - 11**

**A RESOLUTION CONDITIONALLY APPROVING THE APPLICATION  
FOR AN OUTDOOR EVENT PERMIT FOR THE COLORADO BURNAL  
EQUINOX CAMPING, MUSIC AND ART EVENT.**

WHEREAS, the Applicants, Steve Maruska and David Wellhauser, have applied for an Outdoor Event Permit for a camping, music and art event known as Colorado Burnal Equinox on real property described in the Application and addressed as 2703 County Road 68, Bailey; and

WHEREAS, at a regularly scheduled public meeting of the Park County Board of County Commissioners (“BOCC”), preceded by the required public notice, the BOCC conducted a public hearing on the application at which it reviewed the application and all supporting documentation, the recommendations of the Planning Commission, the Planning Department, the County Attorney, and considered the testimony of the Applicant and patrons; and

WHEREAS, based on the evidence and testimony presented at the public hearing the BOCC finds and determines that compliance with the standards for approval of an Outdoor Event Permit set forth in Section 5-707 of the Park County Land Use Regulations has been demonstrated by clear and convincing evidence; and

**NOW THEREFORE, BE IT RESOLVED THAT THE PARK COUNTY BOARD OF  
COUNTY COMMISSIONERS HEREBY APPROVES THE APPLICATION FOR AN  
OUTDOOR EVENT PERMIT FOR THE EVENT DESCRIBED ABOVE SUBJECT TO  
THE FOLLOWING CONDITIONS:**

1. Event duration, as defined in Park County Land Use Regulations Article V, Section 5-707 F, will be from Friday, March 15, 2019 at 11:00 am to Sunday, March 17, 2019 at 11:00 am. Event set-up will take place beginning at 12:00 on Thursday, March 14 with no more than 30 people on site. Event take-down and clean-up will be completed by 12:00 Monday, March 18, 2019 with no more than 30 people left on site.
2. All representations made by the applicant in the application or during the hearing are made conditions of the Permit.
3. If there is any fire ban in effect during the event, no fires of any kind shall be permitted.
4. A Certificate of Insurance for the Event shall be received by the Planning Department within 10 days of approval by the BOCC.

- 5. Event organizers will be responsible for making sure that each campsite has a fire extinguisher and that there are two fire extinguishers for each fire apparatus at the event.
