Resolution No. 2019- 25**

A RESOLUTION AMENDING RESOLUTION 2019-17 AND APPROVING AN APPLICATION FOR A SITE PLAN MODIFICATION AS PART OF THE APPROVAL OF THE APPLICATION OF HOTLEAF, LLC FOR RENEWAL OF ITS RETAIL MARIJUANA CULTIVATION FACILITY LICENSE FOR ITS FACILITY LOCATED AT 30390 HIGHWAY 9, HARTSEL, COLORADO.

WHEREAS, the Applicant, Anthony Miller for Hotleaf, LLC, has applied for a site plan modification and renewal of a retail marijuana cultivation facility license for the facility located at 30390 Highway 9, Hartsel, Colorado; and

WHEREAS, at a regularly scheduled public meeting of the Park County Board of County Commissioners, preceded by the required public notice, the Board of County Commissioners conducted a public hearing on the application for renewal of the retail marijuana cultivation facility license and site plan modification at which it reviewed the application and supporting documentation, and information presented by the Planning Department, and considered the testimony of the Applicant and patrons; and

WHEREAS, based on the testimony and evidence presented at the public hearing the Board of County Commissioners determines and finds that compliance with the standards for modification of a site plan and renewal of the retail marijuana cultivation facility set forth in Park County Ordinance No. 16-01 have been demonstrated by clear and convincing evidence; and

WHEREAS, Park County Board of County Commissioners approved the renewal of the retail marijuana cultivation facility by Resolution No. 2019-17 adopted March 21, 2019, which Resolution was silent on the approval of the site plan modification.

NOW THEREFORE, BE IT RESOLVED THAT THE PARK COUNTY BOARD OF COUNTY COMMISSIONERS HEREBY APPROVES A RESOLUTION AMENDING RESOLUTION 2019-17 AND APPROVING A SITE PLAN MODIFICATION AS PART OF ITS APPROVAL OF THE RENEWAL OF THE RETAIL MARIJUANA CULTIVATION FACILITY LICENSE FOR THE FACILITY LOCATED AT 30390 HIGHWAY 9, HARTSEL, COLORADO.
