**A RESOLUTION APPROVING RENEWAL WITH CONDITIONS OF THE LICENSES OF HOLISTICAL, LLC FOR RETAIL AND MEDICAL MARIJUANA CULTIVATIONS, AND RETAIL AND MEDICAL MARIJUANA PRODUCTS MANUFACTURING, ADDRESSED AS 375 KOKANEE ROAD, FAIRPLAY, COLORADO.**

WHEREAS, the Applicants, Jason Cranford and Jonathan Franklin, have applied to renew the retail and medical marijuana licenses at Fourmile Fishing Club Filing 1 Lot 33, addressed as 375 Kokanee Rd, Fairplay, CO 80440; and

WHEREAS, on May 4<sup>th</sup>, 2021, at a regularly scheduled public meeting of the Park County Board of County Commissioners (“BOCC”), the BOCC reviewed the applications for renewal and all supporting documentation, and the testimony of the Applicants.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF PARK that the following findings of fact and conclusions are hereby adopted.

FINDINGS AND CONCLUSIONS

1. The Applicants stated that they have paid all past-due State marijuana taxes; and
2. Extenuating circumstances, including heavy snows, the pandemic, and limited staffing caused a strain on the Applicants’ businesses.

**NOW THEREFORE, BE IT FURTHER RESOLVED THAT THE PARK COUNTY BOARD OF COUNTY COMMISSIONERS HEREBY APPROVES THE LICENSE RENEWAL APPLICATIONS FOR RETAIL AND MEDICAL MARIJUANA CULTIVATIONS, AND RETAIL AND MEDICAL MARIJUANA PRODUCTS MANUFACTURING LICENSES FOR THE PERIOD FROM MAY 4<sup>TH</sup>, 2021 TO AUGUST 2<sup>ND</sup>, 2021 AND HEREBY ORDERS THAT APPLICANT SHALL SATISFY THE FOLLOWING CONDITIONS:**

CONDITIONS

1. Applicants shall pay the application renewal fees of \$2,100.00 by August 2<sup>nd</sup>, 2021.
2. Applicants shall pay all past-due personal property taxes of \$4,892.44 together with any interest and fees by August 2<sup>nd</sup>, 2021.
3. Applicants shall pay all past-due real property taxes of \$50,278.96 together with any interest and fees by August 2<sup>nd</sup>, 2021.
4. Applicants shall submit all marijuana excise tax forms to the Park County Finance Department and shall pay any interest and fees by August 2<sup>nd</sup>, 2021.

BE IT FURTHER RESOLVED THAT THE PARK COUNTY BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS THAT IF APPLICANTS SATISFY ALL OF THE CONDITIONS, THEN THE LICENSES FOR RETAIL AND MEDICAL MARIJUANA CULTIVATIONS, AND RETAIL AND MEDICAL MARIJUANA PRODUCTS MANUFACTURING (THE "LICENSES") SHALL BE RENEWED FOR THE PERIOD FROM AUGUST 2<sup>ND</sup>, 2021 TO MAY 4<sup>TH</sup>, 2022.

BE IT FURTHER RESOLVED THAT THE PARK COUNTY BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS THAT IF APPLICANTS FAIL TO SATISFY ALL OF THE CONDITIONS, THEN, AFTER NOTICE IN ACCORDANCE WITH THE LAW, A HEARING SHALL BE HELD FOR THE PURPOSE OF CONSIDERING WHETHER TO REFUSE TO RENEW, SUSPEND OR REVOKE THE LICENSES.
