Resolution No. 2021- 32**

A RESOLUTION DENYING AN APPLICATION FROM AQUA FARMS, LLC FOR A RETAIL MARIJUANA CULTIVATION LICENSE FOR A FACILITY LOCATED AT 39329 HWY 285, JEFFERSON, CO 80456.

WHEREAS, the Applicant, Kevin Pham, on behalf of Aqua Farms, LLC, has filed an application for a retail marijuana cultivation license to be located at 39329 Highway 285, Jefferson, Colorado;

WHEREAS, at a regularly scheduled meeting of the Park County Board of County Commissioners ("Board"), preceded by the required public notice, the Board of County Commissioners conducted a public hearing on the application for a retail marijuana cultivation license, at which it reviewed the application and supporting documentation, and the recommendations of the Planning Department, and considered the testimony of the Applicant and Park County residents;

WHEREAS, pursuant to Park County Ordinance Nos. 2016-01 and 2017-01, a canvass procedure was required to determine the desires of the adult inhabitants of the neighborhood that would be affected by the marijuana cultivation facility; and

WHEREAS, on June 15, 2021, the Board designated the "neighborhood" as within a 1-mile radius of the proposed location, and County Staff canvassed the neighborhood by mail with the following results: 6 neutral, 10 opposed, and 3 in support of the requested license.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF PARK that the following findings of fact and conclusions are hereby adopted.

FINDINGS AND CONCLUSIONS

Based on the comments and evidence presented during the public hearing and the results of the canvass, the Board of County Commissioners finds that the proposed facility would be in opposition with, and would not meet, the desires of the adult inhabitants of the neighborhood under consideration.

NOW THEREFORE, BE IT FURTHER RESOLVED BY THE PARK COUNTY BOARD OF COUNTY COMMISSIONERS THAT THE APPLICATION FOR A RETAIL MARIJUANA CULTIVATION LICENSE LOCATED AT 39329 HIGHWAY 285, JEFFERSON, COLORADO IS DENIED.

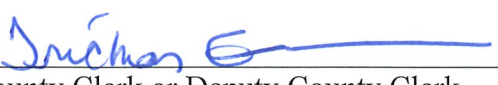
