Resolution No. 2022-08**

A RESOLUTION ESTABLISHING ELECTION PRECINCTS IN PARK COUNTY

WHEREAS, every ten years, the boundaries of legislative districts are redrawn based upon changes in population after each federal census of the United States affecting election districts for the state Senate and the state House of Representatives, as well as election districts for the federal House of Representatives in the United States Congress; and

WHEREAS, under provisions of the Colorado Revised Statutes (C.R.S.) 2-2-506(1)(a) and pursuant to the provisions of Article 5, Part 1, the board of county commissioners of each county shall redraw the general elections precincts in such county to ensure that no general election precinct is contained within more than one state representative. State senatorial, or congressional district; and

WHEREAS, the County Clerk and Recorder has determined for the administration of elections and under the provisions of the Colorado Revised Statutes Article 5, Part 1, the County Clerk and Recorder, subject to approval of the Board of County Commissioners, deems that there needs no change to the current precincts.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of the County of Park County makes no change to the election precincts for all general, primary and congressional vacancy election, and makes no changes to the numbers of each precinct to be in compliance with Colorado Law as shown on the attached maps incorporated herein and by reference made a part hereof.

BE IT FUTHER RESOLVED that this Resolution for precincts in Park County shall supersede any previous resolutions regarding the setting of precincts and numbering.

BE IT FINALLY RESOLVED that the precinct boundaries and numbering as shown on the attached maps and this Resolution shall be reported by the County Clerk and Recorder of Park County to the Secretary of State of Colorado by transmitting a copy of this resolution and the precincts map within ten days.
