Resolution No. 2025- 007

WHEREAS, Park County received \$452,408.83 in Lodging Tax Revenues in 2024 delivered by the State of Colorado, Department of Revenue, and said monies have been deposited to through the Treasurer and recorded by the Budget & Finance Department in Fund 23, Lodging Tax Fund, and

WHEREAS, per the 2023 Ballot Issue 1A, a 2% Short Term Rental Lodging Tax approved by the voters of Park County on November 7<sup>th</sup>, 2023, it is necessary to distribute the funds collected in the following manner:

- 35% to road and bridge operations, capital improvements and related maintenance and equipment
- 35% to law enforcement and public safety
- 20% to the Emergency Services Council
- 10% to advertising and marketing local tourism

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS FOR THE COUNTY OF PARK that:

Twenty percent of the available balance of \$447,884.74 in the Lodging Tax Revenue account be distributed to the Park County Emergency Services Council, equating to \$89,576.95 as outlined in the figures below;


