**A RESOLUTION REPEALING RESOLUTION NO. 37 AND ABOLISHING THE
OFFICE OF COUNTY CHIEF DEPUTY CLERK OF PARK COUNTY CREATED
THEREBY**

WHEREAS, Resolution No. 37, approved and adopted on October 4, 2022 by the Park County Board of County Commissioners ("BOCC"), stated that it established the position of County Chief Deputy Clerk of Park County ("Position"), prescribed the duties for the Position, and enabled a majority of the BOCC to appoint a person to such Position; and

WHEREAS, also on October 4, 2022, the BOCC appointed and entered into an employment agreement with an individual employed by the County Clerk of Park County ("County Clerk") to serve in the Position, which individual provided advance written notice of their resignation from the Position to the BOCC and resignation from their employment to the County Clerk on August 4, 2025, to be effective on August 14, 2025; and

WHEREAS, although C.R.S. § 30-11-107(1)(n) authorizes the BOCC to create by resolution any such office as may, in its judgment, be required for the efficient management of the business and concerns of the county and to make appointments, prescribe duties, and fix the compensation for such offices, C.R.S. § 30-10-403 specifically requires the County Clerk to appoint a deputy, in writing, and authorizes such deputy to perform all the duties of the County Clerk during an absence, vacancy, or disability of the County Clerk; and

WHEREAS, because state law requires the County Clerk to appoint a deputy via written appointment on file in the office of the county clerk, and because the individual holding the position of County Chief Deputy Clerk created by the BOCC in 2022 has resigned from that office as well as from their employment with the County Clerk, the BOCC finds that there is no need for a separate position of County Chief Deputy Clerk and desires to repeal Resolution No. 37 and abolish the office of County Chief Deputy Clerk created thereby, without impairing or interfering with the County Clerk's ability to appoint a deputy pursuant to Colorado law.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of the County of Park that:

Section 1. Recitals Incorporated. The foregoing recitals are hereby incorporated into this Resolution.

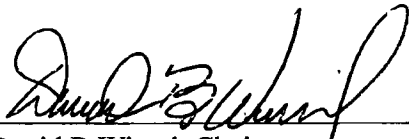
Section 2. Resolution No. 37 Repealed. The Board of County Commissioners hereby repeals Resolution No. 37 that was approved and adopted on October 4, 2022 and abolishes the office of Chief Deputy County Clerk created thereby. This repeal and abolition shall not impair or interfere with County Clerk's ability and authority to appoint a deputy pursuant to Colorado law.

Section 3. Severability. If any part or provision of this Resolution is adjudged to be unenforceable or invalid, such judgment shall not affect, impair, or invalidate the remaining provisions of this Resolution, it being the BOCC's intention that the various provisions hereof are severable.

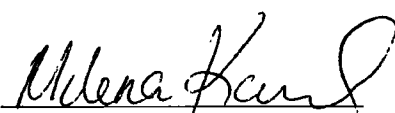
Section 4. Repeal. All acts, orders, and resolutions, or parts thereof, of the BOCC that are inconsistent or in conflict with this Resolution are hereby repealed to the extent of such inconsistency or conflict.

Section 5. Effective Date. This Resolution is effective upon adoption.
